Agenda item 1 - Previous minutes and matters arising

1. The Bureau agreed the minutes of its meeting on 12 November.

### Agenda item 2 - Business Programme

- The Bureau agreed a revised programme of Business for the week beginning 18 November and a programme of business for the weeks beginning 25 November and 2 December.

- 4. Business Managers discussed an approach to proposed emergency legislation to introduce changes to the release point for prisoners. The Bureau noted —
- The Scottish Government's proposal that, subject to the Parliament's agreement to treat the Bill as an emergency bill, Stage 1 of the Prisoner Release (Scotland) Bill would take place on Thursday 21 November and Stages 2 and 3 on Tuesday 26 November and noted that a Bureau motion including these dates would be lodged.
- that the Presiding Officer would consider a suitable deadline for lodging of Stage 2 amendments and advise Business Managers in due course.

### Agenda item 4 – Approval of an SSI

- 5. Business Managers noted that a motion would be lodged to approve the following instrument—
- Funeral Expense Assistance (Scotland) Amendment Regulations 2024 (SSI 2024/Draft)

Agenda item 5 – Establishment of a Committee

- 6. Business Managers agreed—
- to establish a Committee of six Members, to be drawn from the six parties represented in the Parliament, with an SNP Convener and no deputy Convener;
- a draft remit for the Committee
- that the duration of the Committee would be until 30 September 2025.
- that a motion setting out these details and details of membership would be circulated for the Bureau to agree before lodging.
