- **4. First Minister's Statement:** The First Minister (John Swinney) made a statement and answered questions on Infected Blood Inquiry.
- **5. Post Office (Horizon System) Offences (Scotland) Bill:** The Cabinet Secretary for Justice and Home Affairs (Angela Constance) moved S6M-13292—That the Parliament agrees to the general principles of the Post Office (Horizon System) Offences (Scotland) Bill.

6. Post Office (Horizon System) Offences (Scotland) Bill: Financial Resolution: The Cabinet Secretary for Justice and Home Affairs (Angela Constance) moved S6M-13232— That the Parliament, for the purposes of any Act of the Scottish Parliament resulting from the Post Office (Horizon System) Offences

(Scotland) Bill, agrees to any expenditure of a kind referred to in Rule 9.12.3A of the Parliament's Standing Orders arising in consequence of the Act.

7 Motion Without Notice: The Minister for Parliamentary Business (Jamie Hepburn), on behalf of the Parliamentary Bureau, moved without notice that, under Rule 11.2.4, Decision Time be brought forward to 5.28 pm.

- **8. Decision Time:** The Parliament took decisions on items 5 and 6 as noted above.
- **9. National Epilepsy Week:** The Parliament debated S6M-13087 in the name of Marie McNair—That the Parliament recognises National Epilepsy Week, which runs from 20 to 26 May 2024; notes that this takes place to raise awareness of epilepsy, the challenges that those living with the condition face and to promote greater understanding and inclusion; further notes, in particular, the employment challenges that can face those living with epilepsy; understands that it is the most prevalent of the main neurological conditions, with around 58,000 people living with epilepsy in Scotland; recognises what it sees as the importance of National Epilepsy Week to foster conversations and greater understanding amongst the general public of the condition and what to do when someone has a seizure; welcomes the work of local groups such as West Dunbartonshire Epilepsy Support Group and, nationally, Epilepsy Scotland, for what it regards as the vital social support services that they provide to those living with epilepsy, but notes the reported difficulties that they are facing through independently funding these services, and hopes for a productive and successful National Epilepsy Week.
