The Food and Feed (Miscellaneous Amendments) Regulations 2022

EU EXIT LEGISLATION – PROTOCOL WITH SCOTTISH PARLIAMENT

The Scottish Parliament agreed on 06 October 2022 that it was content for Scottish Ministers to give their consent to the proposed GB Statutory Instrument (SI), 'The Food and Feed (Miscellaneous Amendments) Regulations 2022' including Scottish devolved matters, as set out in the notification to the Parliament.

Following scrutiny by the UK Parliament, 'The Food and Feed (Miscellaneous Amendments) Regulations 2022' was made on 14 December 2022 under section 8(1) of, and paragraph 21 of Schedule 7 to, the European Union (Withdrawal) Act 2018.

I can now confirm that no substantive changes have been made to the GB Statutory Instrument since the notification. Therefore, the SI as made is consistent with the notification and the consent given.
