# Advancing World-Class Eye Care in Scotland

STRATEGY 2024-2027

On behalf of Optometry Scotland and all our members, I am pleased to present our strategy for 2024-2027, which sets out how we intend to continue to advance world-class eye care in Scotland.

As a sector, we have much to celebrate and of course there have been some fantastic achievements over the past few years.

Up until 2021, the optical sector was the only primary care provider without an annual fee review process, so it is extremely welcome that the Scottish Government has acknowledged and remedied this. Securing an annual fee review mechanism for the sector, particularly the most recent 6% uplift in GOS fees in 2023/24, on top of additional increases in the previous two years is a key highlight.

While there is much to be proud of, there is still work to be done to collectively ensure that eye care in Scotland becomes more accessible and is available to those who need it.

The new education and training requirements (ETR), widening the use of OCT technology, preserving GOS, community glaucoma work and changes to staffing legislation are issues which will affect us all.

We must also make sure our world-class service is sustainable and effectively supports the workforce and our businesses and livelihoods whilst promoting optometry and related positions as an attractive profession.

Our strategy therefore sets out our three key priorities. The focused action plan will allow us to continue to lead the GOS and service enhancement agenda for community eyecare, while influencing policy direction and workforce development. The overall objective to further building a collaborative voice for community eyecare in Scotland.

Thank you for your continued support of Optometry Scotland. We are proud to represent you and look forward to what we can achieve, working both for you and with you, over the coming years.



### **To Lead the GOS and Service Enhancement** Agenda for Community Eyecare in Scotland



Secure sustainable funding mechanisms for community eyecare services

#### We will:

- Develop a robust GOS review mechanism with the Scottish Government to ensure the integrity of eye health care in Scotland; and monitor and evidence the economic impact in collaboration with optometry
- · Continue to support the development of the Community Glaucoma Scheme, and work with the Scottish Government to establish the Anterior Eye Scheme and Low Vision Scheme
- Work with the Scottish Government to ensure the sustainability of domiciliary care provision in Scotland



#### Explore technological advances to improve future eyecare provision

We will:

- Ensure the value of a comprehensive consultation is known, understood and acted on by professions and policy-makers by developing a robust communication campaign in partnership with key stakeholders
- Call on the Scottish Government to provide financial support to ensure the provision, and sustainability, of digital equipment is fair and equitable for the profession and patients across Scotland



#### Ensure access to essential eyecare services in the community to support other NHS services

We will:

- Continue to drive the shift in balance of care from hospital and GPs to enhanced optometric services by highlighting benefits, and capacity, of the sector to the Scottish Government and key decision makers
- Negotiate and support the implementation of future enhanced service delivery by liaising with members to determine capacity and potential; and maintain dialogue with the Scottish Government to present opportunities and capability of the sector

#### **To Influence Policy Direction and Workforce Development for Community Eyecare in Scotland**

AIM

Ensure community eyecare remains a priority policy and is equally valued within the healthcare sector

#### We will:

- · Continue to act as the first point of contact for all key health spokespeople and political parties to raise awareness, and support, for priorities within community optometry
- Work with partners to embed optometry as an integral part of the public health strategy
- Maintain our position as a sector thought leader and represent members on key working groups and committees across Scotland
- Work with key stakeholders to preserve the requirement for regulation in eyecare examinations and treatment

#### Ensure the sector has a highly skilled and sustainable workforce

#### We will:

- · Work with partners across Scotland to support and promote optometry as a career pathway of choice
- Continue to support partners to effectively implement Education Training **Requirements within Scotland**
- Ensure members have consistent access to a high standard of training and development
- Call on the Scottish Government and NHS to fund the upskilling of the profession to align with and enable the provision of enhanced services across Scotland
- Call on the the Scottish Government to fund sufficient training places at Higher Education Institutions and in the community to meet future workforce requirements
