# **West Lothian Council Housing Emergency Action Plan 2024/25**

# 1. Executive summary

Following the declaration of a housing emergency by West Lothian Council on 28 May 2024, the council has developed this Housing Emergency Action Plan (HEAP) within the context of existing resources available to the council across both the General Fund and Housing Revenue Account (HRA) in the absence of additional Scottish Government grant or subsidy funding available to councils as a result of the housing emergency declaration.

The strategic approach for ending homelessness is laid out within the council's Rapid Rehousing Transition Plan (RRTP) however following extensive ongoing financial pressures the council has also developed a Housing Need Improvement Programme which has a range of targeted measures aimed at reducing costs and improving income generation that are linked to improving the overall service provision of homeless services. The Housing Need Improvement Programme is set out in Appendix 1.

# 2. Housing Emergency Action Plan

The Leader of the Council, Executive Councillor for Housing and senior council officers met with the Minister for Housing and Scottish Government officials on 8 July 2024, and asked for the following measures to be taken by Scottish Government to support the council to mitigate the housing emergency and effectively deliver statutory homeless services that meet statutory duties and legal responsibilities to tenants and other housing customers:

The Housing Emergency Action Plan calls on Scottish Government to take measures to support the council to mitigate the housing emergency and effectively deliver statutory homeless services that meet statutory duties and legal responsibilities to tenants and other housing customers. The Leader of the Council, Executive Councillor for Housing and senior council officers met with the Minister for Housing and Scottish Government officials on 8 July 2024, and asked for the measures set out in the Housing Emergency Action Plan to be taken by Scottish Government.

The Council's Housing Emergency Action Plan is seeking that the following measures are taken by Scottish Government:-

- Fully reverse the cut to the Affordable Housing Supply Programme
- Increase funding available to local authorities for Open Market Acquisitions (OMAS)
- Increase funding via the RRTP to fully fund homeless prevention services until the end of the parliamentary session and provide clarity on future funding
- Provide funding for acquisition of empty homes and the necessary repairs required to bring these homes up to lettable standard.
- Target additional revenue funding specifically at Local Authorities, including West Lothian Council, identified as being at risk of systemic failure in their homelessness services
- Suspend the implementation of the Ask and Act provisions in the Housing (Scotland) Bill
- Suspend the removal of local connection for the duration of the national Housing Emergency
- Suspend the provisions of the Unsuitable Accommodation Order for the duration of the national Housing Emergency
- Take action to address lengthy delays by energy suppliers in replacing or updating meters
- Provide details of the funding allocation to the council from the £80 million to be made available over the next 2 years for new acquisitions.

# **Appendix 1 – Housing Need Improvement Programme**

The Housing Need Improvement Programme builds upon the existing actions within the RRTP and aims to mitigate the housing emergency.

The improvement actions have been aligned to the existing 4 high level actions within the RRTP:

- 1. Increase focus on early intervention, prevention and housing options to stop homelessness happening in the first place;
- 2. Improving access to affordable housing options and reducing lengths of stay in temporary accommodation by improving the flow through the system diverting away from the use of B&B Accommodation:
- 3. Ensure where homelessness does occur that housing options are focused on enabling households to navigate through the system as quickly as possible;
- 4. Implement actions required to ensure people have access to the required levels of support.

The actions are the first step in responding to the housing emergency declaration with separate 36 actions for completion over the next 18 months. It will form the baseline for the next iteration of RRTP which is currently in development.

The imbalance between supply and demand for permanent social rented accommodation continues to be the key challenge in West Lothian and is the key driver of the ongoing breach of statutory duties and budget pressures that are experienced within the council due to the high reliance of unsuitable accommodation.

The need for affordable social housing in West Lothian remains high due to the high number of applications for housing, high sustainability and low turnover of properties.

Low wages, reduced disposable income and increased mortgage rates continue to drive people of West Lothian to regard council and RSL housing as the main affordable housing option.

Table 1 shows that despite decreases in homeless demand over a 5-year span, the number of placements in temporary accommodation increased by 18.7% including B&B placements by 9% in 2023/24. The number of breaches of the Unsuitable Accommodation Order (UAO) also increased, although only marginally by 1%, however over the 5 year span the extension of the

UAO order saw this increase by 181%. This is due to the reduced throughput in temporary accommodation, as despite an increase in the number of households exiting temporary accommodation, the number of permanent lets available to homeless households is not increasing at a rate to match demand, despite a modest increase of 2.2% in 2023/24. The number of lets continues to be low and affected by high sustainability and has decreased by 40% over the 5-year period. This means that homeless demand now outstrips supply by over 301%. If lets to homeless households were increased to 100% it would remain insufficient to meet demand.

Good progress has been made on the delivery of the RRTP in 2023/24 against a back drop of pressures in homeless services and in light of limited financial resources from the Scottish Government to deliver RRTPs. Additional council funding has also been utilised to address critical pressures and to enable transition to a prevention-based approach within the Housing Need service. A programme of structural and operational review has also prioritised the highly effective prevention work which has resulted in reduced homeless applications, significant savings and improvements to practice, partnerships and outcomes.

The operating context has now changed significantly and West Lothian is experiencing a housing emergency with supply pressures not predicted to ease over the next 3 years as demand for homeless services in West Lothian is predicted to remain high due to the ongoing costs of living crisis, increased mortgage costs, higher rent in the private sector and changes to homeless legislation.

The Improvement Programme highlights the key areas of work to be undertaken by the council and its partners to mitigate the housing emergency within West Lothian. These actions will be further supported with an updated Homeless Strategy in 2025/26 that will build on the success of the previous RRTP and support the council to continue working towards long-term changes in service provision whilst aligning with the new prevention duties. This will be achieved through a sharper focus on preventative approaches and a stronger partnership approach.
