Thank you for inviting me to give evidence to the Committee around the recent use of Written Authority for the completion of Hull 802 at Ferguson Marine Port Glasgow (FMPG).

I indicated early on during the Committee session that I would provide a timeline of the process involved in reaching my decision to provide Written Authority to the Accountable Officer, Gregor Irwin.

The Committee will be aware that the Scottish Government commenced a due diligence exercise following the significant increase in cost provided by the CEO of FMPG. This process began on 27 September 2022 and concluded when I provided my statement to the Scottish Parliament on 16 May 2023. The key dates are as per the below:
