- 1. NB. The estimating method applied here reflects the position that trip based data from years *subsequent* to the bass measures being introduced from 2015 cannot be utilised to analyse the effects of applying more flexibility for trawls/seines than has featured so far in the per day/cap per month limits since 2015. The method has relied upon checking 2011-13 data forecasts against one alternative limit scenario for demersal trawls against the *actual* limit and outcome from the limits applied in 2017 and using the % difference between forecast and actual outcome (forecast reflecting 59% of actual) as a 'tuning' adjustment for examining alternative limit estimates (i.e. 5% per day at 400kg per month) based on the 2011-13 average data.
- 2. UK landed 66 tonnes with the <u>3% per day/400kg cap per month</u> limits set in 2017. Trawl and seine landings in 2017 according the ICES catch distribution by fleet table 10 for that year indicates an <u>EU total of 325 tonnes</u>. The above prediction for the same limits based on the 2011-13 UK average trip level analysis shows an outcome of 48 tonnes, and taking away the Feb/Mar closed season tonnage provides a figure of 39 tonnes (which is 59% of the *actual* 2017 landings for trawl/seine at 66 tonnes for UK).
- 3. Selecting a 5% cap per day/400kg cap per month in the above table above suggests an outcome of 54 tonnes all year for the UK based on 2011-13 average trip level analysis: removing the Feb/Mar closed season tonnage indicates a total of 45 tonnes. In 2018 UK took 21% of the EU demersal trawl/seine landings total according to the relevant 2018 table 10 catch distribution by fleet assessment in ICES advice (EU: 136 tonnes; of which UK accounted for 29 tonnes). Taking the 45 tonnes estimate from setting a 5% cap per day/400kg cap per month from the above table and applying the same 59% adjustment ratio as identified in paragraph 2 to estimate the probable actual outcome by applying this limit in 2020, would suggest a UK landings tonnage at 76 tonnes. As the most recent UK share of the EU trawl/seine total landings was at 21%, in 2018 (i.e. EU bottom trawlers and seines at 17% of the EU total landings 801=136, with UK demersal/seine landings at 29 tonnes that year suggests UK share = 21%), UK outcome at 76 tonnes would suggest an EU total of 364 tonnes demersal/seine landings.
