5 Headlines

Carlene McAvoy highlighted the contents of the Headlines Newsletter (appendix 1) which had previously been circulated.

6 Speakers

Gill Burton, Scottish Cot Death Trust: Safe sleep for early years care

Gill works as Education Manager for the Trust and manages their training provision which includes safe sleep education, SUDI training for community health and social care professionals and simulation training for NHS staff, police and Scottish Ambulance Service.

Katrina Phillips, CAPT: Child Safety Week

Katrina is the Chief Executive of the Child Accident Prevention Trust, a charity working across the UK to reduce avoidable death and serious injury to children. Yesterday she received an OBE for services to child safety. She will be talking about Child Safety Week 2024 and safety concerns on CAPT's radar.

Marie Spiers, NHS Greater Glasgow and Clyde: Severe Injury in children and young people

Marie has been a consultant in paediatric emergency medicine at the Royal Hospital for Children, Glasgow since 2012. Marie is dual accredited in adult and paediatric emergency medicine and trained in the West of Scotland and North West of England after graduating from Glasgow. She is a joint paediatric trauma lead for the West of Scotland and the national paediatric representative for the Scottish Trauma Audit Group (STAG).

7. Discussion

Clare Adamson suggested to Gill and Katrina that they could work with food banks and Nurture Scotland (who support kinship carers); Claire will link them up.

Brian Topping asked Gill to clarify guidance about smoking. Gill confirmed that parents are discouraged from smoking and smoking cessation schemes are promoted, but the focus is on educating about the increased risk to SUDI in a non-judgemental way, so the parents understand how to reduce the risk of harm to the health of their baby whatever their smoking status is, e.g. changing into clean clothes before holding the baby. William Harley asked Gill whether car seats are covered in the training. Gill confirmed they are included, particularly with parents, as they talk about car seats not being a suitable sleep space and how long babies can be in them generally.

Clare thanked Michelle McKenna for bringing examples of unsafe products to the meeting. Michelle explained that everything she brought was recalled or withdrawn from the market, the majority were found online and are often raised to Trading Standards when people have had an incident or accident with the product.

Clare reminded the group of funding cuts to both CAPT and RoSPA in home safety and asked Marie what the cost of an average stay for unintentional injury is, Marie said she would get the data and send it on.

Clare then went on to talk about the British Standards Institute conference being held in Scotland in November and asked if there was potential for the CPG to engage; Michelle will look into this via CPIN.

Appendix 1 Headlines Newsletter

Water-related fatality data release

WAID 2023 data was released on the 30_{th} May and a full trend report has been published by RoSPA and Water Safety Scotland.

• Overall, water-related fatalities have decreased in comparison to the Scotland baseline average (2024: 94 vs basline:96)

- Of the 94 water-related fatalities, there were 47 accidental fatalities.
- 86% of accidental fatalities were male
- Males aged 60-69 were the highest group for accidental fatalities
- 64% of accidental fatalities happened at inland waters
- Everyday activities accounted for 59% of accidental fatalities

• The rate of accidental water-related fatalities is coming down . 2023's rate was 0.86 per 100,000 vs the baseline of 0.96 per 100,000.

World Drowning Prevention Day

Water Safety Scotland, alongside our partners the Darcey Sunshine Foundation, Scottish Water, SFRS and Argyll and Bute council, are hosting a Water Safety Open Day in support of the UN's World Drowning Prevention Day on the 25th of July. This is the third year in a row that WSS is hosting a day suchlike. However, this year, the event is taking place at Loch Lomond Shores in Balloch, from 11am to 4pm.

The event aims to raise awareness of water safety with as many members of the public as possible, to promote an increased knowledge of the potential dangers – whilst still encouraging people to take part in water-related activities in a safe and enjoyable manner. We have various stand holders, demonstrations and activities planned, from Stand-Up Paddleboarding sessions, an art/poetry corner, and an orienteering course, to ensure a fun filled day for everyone.

Events such as this are imperative because on average 96 people drown each year in Scotland – a number disproportionate when compared to our UK neighbours. Water Safety Scotland and its partners work tirelessly to reduce drowning fatalities through Scotland's Drowning Prevention Strategy and the Minister's Action plan, which is led by the Minister for Victims and Community Safety, Siobhian Brown (MSP).

Water Safety mini toolkits

For the month of May, Water Safety Scotland's comms themes were Kayaking/Canoeing and Stand-Up Paddleboarding. The focus on these activities in May was due to previous WAID data showing that May is a month with high rates of accidental drowning when Kayaking/Canoeing or SUP. The mini comms toolkits are created for ease of distribution by our partners in the comms Subgroup. Social media assets detailing the water safety code specific to these sports were created, alongside pre-written tweets to be posted on social media pages. The water safety code for Kayaking/Canoeing was created with help from our partners Paddle Scotland and Glenmore Lodge. Our SUP water safety code was supported by Paddle Scotland, Glenmore Lodge, and the Scottish Surfing Federation.

To marry well with the social media assets, WSS worked with our partner Paddle Scotland to create videos that detailed the water safety codes specific to these sports. Paddle Scotland's Development Manager, Calum McNicol took the lead in these videos to detail how to take part in these water-based activities, supported through his invaluable knowledge and expertise of the sports. These videos were filmed at a common site for both of these sports and captured Calum actively setting up and partaking in the sports. These visual aids help support the learning of the three step water safety code.
