**Meeting April 29 2024:** Five MSPs, Miles Briggs, Monica Lennon, Fergus Ewing, Rhoda Grant, Jeremy Balfour. 43 non MSPs.

Miles Briggs, chairing, said membership of organisations and individuals continued to increase.

TALK: Children and young people in pain. Dr Emma France, Stirling University drew attention to between 20% and 35% of children and youths suffering non-cancerous long term pain.

SECRECY: this continues over a report costing £40,000, arranged by officials, which no-one will answer on claims of flaws. MSPs agreed to write to the health secretary and the head of the Civil Service. Also,a mesh victim reported quitting a Govt advisory group on patient safety as it was "very secretive"

NHS Highland threat: After CPG intervention by MSPs and the secretary, the Board agreed to extend a specialist pain relief consultant contract - but only until a 2026 decision on all Scottish pain services for outpatients. We continue the battle for permanent help. Meeting objected to delay of four years of behind scenes talks on all Scotland pain services. 2022-2026.

Meeting & AGM November 20, 2024: Four MSPs: Miles Briggs, Monica Lennon, Fergus Ewing, Foysol Choudhury. 35 Non MSPs.

Conveners elected: Miles Briggs, Clare Adamson. Voluntary Secretary: Dorothy-Grace Elder.

TALK: Dr Rianna Price of Inclusion Scotland outlined why three charities-Inclusion Scotland, Glasgow Disability Alliance and Disability Equality Scotland resigned from a Scottish Government advisory group, calling it "a sham process". They launched "Disabled People demand Justice"

TALKS: Fibromyalgia updates from Sharon Turnbull, Coatbridge, who founded "More than Fibro" and Hazel Borland from Fibromyalgia Action UK. Update on Centre forIntegrative Care - Dr Patrick Trust.

Voluntary Secretary Report: Secrecy continues and lack of Government and civil service response to letters. JP Marks, head of Scottish Civil Service, did not reply to MSPs' letter, which patients had requested in April.

The group had numerous other activities, including: February 2024 CPG arranged meeting of Highland MSPs, all Parties, Highland patient reps and a health professional over fears for Highland pain services. Rona Mackay MSP chaired.

CPG briefed on a meeting between MSPs and minister Jenni Minto. MSPs objected to patients not being allowed.

CPG secretary sent numerous submissions on lack of action for patients and used FOI repeatedly due to lack of information to pain patients. \*CPG chieved through FOI the release of a pain report which had been withheld for two years on the pain residential service . The report was actually good news -the centre was judged valuable for help.

Visit by some group members and secretary to Fibromyalgia UK in Paisley and More than Fibro, regular visits to relevant other CPGs on Arthritis & MSK, Women's Health, Long Covid.
