## Agenda item 1 - Welcome and Introductions

The Convenor welcomed everyone to the meeting and reminded people to say who they were and what organisation they represented before making contributions.

He asked Amy White to check accessibility and ensured everyone could access the meeting effectively.

## Agenda item 2 - Attendance, Apologies and Members

Attendance and apologies noted in the minutes.

The group approved a proposal to add Lothian Deaf Children's Club, and to welcome a member of the Scottish Youth Parliament to future meetings.

# Agenda item 3 – Approve the minutes from last meeting and discuss matters arising

Minutes of meeting on Wednesday 11 September and 1 October (AGM) were approved. Matters arising are substantive on the agenda.

The convenor noted actions the re-election of convenor and vice convenors, and the appointment of new secretariat. Finally, the Convenor shared sincere thanks to Janis McDonald, stepping down as secretariat, who has given tremendous service.

Under matters arising, Hannah Tweed highlighted the news from Scottish Government officials that there will no longer be a refreshed See Hear Strategy. Group expressed considerable disquiet at news and possible responses.

**Actions:** Hannah Tweed to circulate stakeholder letter with minutes, and to reach out to CPGD on Visual Impairment about a joint letter of concern to Ministers (Maree Todd, Neil Gray) and the Equalities, Human Rights and Civil Justice Committee.

Group also discussed audiology update.

**Action:** CPGD to write to Jenni Minto in January requesting a Parliamentary update on progress, and to invite her to speak to the CPGD on 5 February or 28 May.

Group discussed Education (Scotland) Bill and inclusion of BSL.

**Action:** CPGD to write to Jenny Gilruth in support of proposals to include BSL.

## Agenda item 4 – updates from working groups

#### **Definition of Deafblindness**

As Annabelle Ewing MSP could only stay for first part of meeting, Isabella Goldie talked through the updates circulated prior to the meeting and progress that had been made since September 2024.

Civil servants have stated that even with the cancellation of the See Hear Strategy refresh, the definition of deafblindness work and guidance will have a new policy home and continue. We hope to see guidance and clarity on new contact soon.

#### **Qualified Teachers of the Deaf/Attainment**

Karen Adams MSP noted the work done by the working group, planned steps to raise the issue with Jenny Gilruth, and summarised the final version of the report circulated to the CPGD. Mark Ballard invited final comments on report and for approval to publish and launch in 2025. Group discussed final edits, and approval given.

**Action:** The working group will finalise report and commission a BSL summary, for launch in 2025. Mark Ballard will share launch details and comms plan with CPGD members in January.

## **Sensory Care and Dementia**

Roz McCall MSP noted that the working group has completed four surveys about referral pathways, with good response rates, and a draft report has been shared with the working group. The final report should be ready to be shared with CPGD at next meeting on 5 February. Amy White noted that we now have wider lived experience representation on working group.

**Action**: Working group to provider longer summary of full report for comment and approval at next CPGD meeting on 5 February.

#### Agenda item 4

BSL Plan Implementation. See attach PowerPoint for detailed information.

Kevin McGowan, Unit Head for the Equality Division, including responsibility for BSL within Scottish Government, and Andrew Godfrey-Meers, BSL Policy Manager attended. Kevin McGowan summarised progress on the BSL national and local plans, and priorities for 2025.

**Action:** Kevin McGowan committed to responding to any questions in writing after the CPGD.

#### **Termination notice for Contact Scotland BSL**

The CPGD have been informed that Sorenson/SLI have received a termination notice for the Contact Scotland BSL service from March 2025. We understand that there is no intention that the contract will be continued in another form or open to tender. Service will end in March 2025 under current plans. Group expressed considerable concern at this news. Kevin McGowan shared that procurement rules mean that the contract has been renewed the maximum number of times allowed, and noted calls for an impact assessment. Karen Adam suggested writing to

the Equalities, Human Rights and Civil Justice Committee about the issue, in advance of next meeting on 17 December.

**Actions:** CPGD to draft letter of concern on decision to terminate Contact Scotland BSL service, without consultation. Letter to be sent to Equalities and Human Rights Committee by 16 December, and drafted by subgroup of members who volunteered to be involved (BDA, Deaf Action, RNID, NESS, Deafblind Scotland, the ALLIANCE). Kevin McGowan to discuss CPGD response with colleagues.
