Group Meetings and Activities

25th October 2023 - 3 MSPs (John Mason, Murdo Fraser, Jeremy Balfour) and 20 non-MSPs. The AGM reviewed the past year's work and re-elected John Mason MSP as Convener. Discussions covered rising hate crimes, workplace discrimination, and struggles of faith-based asylum seekers. Attendees stressed education, interfaith funding, and advocacy on issues like cemeteries legislation and faith literacy, with plans for future actions.

27th March 2024 - 3 MSPs (John Mason, Stephen Kerr, Pam Gosal) and 25 non-MSPs. Professor Nazila Ghanea, UN Special Rapporteur on Freedom of Religion or Belief, presented on religious hatred and freedom of religion as a universal human right. Discussions addressed legal standards, societal challenges, and advocacy opportunities. The meeting emphasised the group's role in knowledge-sharing and advancing interfaith dialogue.

11th November 2024 - 3 MSPs (John Mason, Stephen Kerr, Murdo Fraser) and 14 non-MSPs. John Kinahan from Forum18 detailed violations of religious freedom in Russia and Russian-controlled Ukraine, including persecution, torture, and censorship. The group discussed international human rights mechanisms and geopolitical issues. The meeting concluded with approval of the previous minutes.

25th November 2024 - 4 MSPs (John Mason, Jeremy Balfour, Stephen Kerr, Murdo Fraser) and 2 non-MSPs. The AGM was held to meet the 13-month requirement. Interfaith Scotland announced its retirement as secretariat, with no replacement yet appointed. A review of the year highlighted October's interfaith dialogue, March's presentation by Dr. Nazila Ghanea, and November's talk by John Kinahan. John Mason MSP and Murdo Fraser MSP were re-elected as Convener and Deputy Convener.
