The first was from the Consul General of Japan in Edinburgh, Mr Tadashi Fujiwara. This provided an overview on the recent developments in Scottish and Japan relations.

The second was a presentation from Professor Emeritus Ian Gow, Honorary Professor East Asian Studies at Edinburgh University on First Contact: The Earliest Scots in Japan. There was then a discussion and question session following the Consul General's presentation. The meeting also touched on topics that could be covered at future CPG meetings.

Further, Colin Smyth in his role as Convenor, took part in a number of events over the summer period including addressing the reception hosted by the Consul General of Japan in Edinburgh to celebrate the many performers from Japan taking part in the Edinburgh fringe as well as the Japanese Summer Festival in Shambellie House, Dumfries organised by JET AA (JET Alumni Association).

On 10 September 2024 the group held a further meeting including it's annual general meeting in TG24. At this meeting the secretariat was appointed. The Group also shared views in relation to potential *themes* which could also be considered. The next substantive meeting is due to take place in November or December 2024.
