Creative Scotland - Multi-Year Funding Outcomes

- Alan Morrison - Head of Music at Creative Scotland spoke about the outcomes of the Creative Scotland multi-year funding outcomes.

- Morag Macdonald from the Youth Music Initiative at Creative Scotland spoke about the outcomes for the youth, community and educational sector.

The outcomes were generally well received. More money will be available in years 2 and 3. The funding has supported more diversity in genre and geography.

- Lottery funding was not required due to the Government uplift.
