Liz Smith MSP led a wide-ranging discussion on investment in outdoor education, the drivers, barriers and what is needed to meet the ambitions of universal provision. Presentations were delivered by:

- Nick March of AHOEC, who set the scene for the other speakers, providing an overview of the current building stock of the Scottish outdoor education estate which he described as the most significant investment challenge facing outdoor educators.
- Neil Baird, Head of Outdoor Education at Scouts Scotland, who gave an overview of the charity's investment model and the upkeep challenges it was facing.
- Avril Nicol, Head of Service for Communities, Wellbeing & Partnerships at Aberdeenshire Council, who discussed the opening of a new centre in the region and the investment journey that funded it.

Meeting 12 September 2024

Liz Smith led a discussion on best practice in including young people with Special Educational Needs in outdoor learning, with a view to harnessing this in delivering future universal provision. Presentations were delivered by:

- Iona McCroary the Principal Teacher of Etive House, on best practice in outdoor education provision for autistic children.
- Jamie Miller, the CEO of Scottish Outdoor Education Centres on meeting the needs of different types of disability groups at residential centres.
- Phil Thompson of Ardroy Outdoor Education Centre and Fiona Robertson of Denbeath Primary School, presenting their codesigned tool that helped one neuro-diverse pupil overcome anxiety ahead of a residential experience.
- Pete Moir, Scottish Operations Manager of Duke of Edinburgh, on supporting young people with additional support needs to participate in the Duke of Edinburgh programme.
