Thank you for your recent letter to the Convener of the Citizen Participation and Public Petitions Committee in regard to petition <u>PE2048: Review the</u> <u>FAST stroke awareness campaign</u>.

As you have noted, this petition is currently under consideration with the Committee having agreed to invite written evidence from the Minister for Public Health and Women's Health, the Stoke Association, and Chest, Heart and Stroke Scotland. <u>All written submissions received on PE2048 are available on the petition history webpage.</u>

3 Discussion topic: the Stroke Improvement Plan one year on.

Speakers:

Dr Matt Lambert. National Clinical Lead for Stroke and Specialty Advisor on stroke to the Chief Medical Officer.

John Watson. Associate Director, Stroke Association in Scotland.

Dr Lambert offered his perspective, focussed on stroke as part of the wider health and social care landscape and its connectivity to other areas of health care.

Key points

- Leadership is required to deliver improvements
- Low priority is given to stroke in comparison to other areas e.g. emergency department four hour waiting time targets, outpatient waiting lists
- Pressures in wider system
- Workforce recruitment and retention

Thrombectomy is still seen as new service and an optional extra rather than standard medical procedure.

Staff recruitment and retention is a major issue for stroke and the thrombectomy programme

Effect of Capital build freeze for thrombectomy also a major problem

Question of whether consideration needs to be given inside Boards as to whether other procedures/activities need to be de-prioritised, given limited capacity

Reflections on plateauing or deterioration in some instances of performance as shown in July's SSCA figures

John Watson spoke of Stroke Association priority areas including FAST, psychological care, hyperacute care and rehab. Showed RAG chart info and SSCA data.

Key points

- Leadership required
- Latest SSCA data shows Scotland is not performing well.

4. Discussion



General discussion followed, focussed on issues raised by Dr Lambert and John Watson.

Convenor proposed the following actions, which were agreed by the group:

- Convenor to write to Chair of the National Thrombectomy Planning Board re. the funding gap in the East of Scotland, to ask what the delay on payment is and for an explainer on internal workings of Scot Gov funding for thrombectomy programme
- To raise a couple of Parliamentary Questions on recurrent funding and barriers to progress for thrombectomy
- Re. senior leaders from Health Boards meeting 10 October to write to the Minister responsible for stroke Jenni Minto MSP to ask that she deliver a message of encouragement and expectation to that meeting from this CPG. And to ask for a written update for the CPG on how the meeting goes.
- Ask PQ on Leadership of the 14 Health Board 'named individuals' and how it will measure progress on delivery
- Convenor to write to the Finance Minister re. challenges posed to thrombectomy development by lack of recurrent funding

5. AOB

- CHSS FAST campaign will launch around World Stroke Day 29 October.
- Next meeting is Friday 6 December. Topic as previously agreed will be rehabilitation.
