*S6M-14922 Karen Adam: Celebrating One Parent Families Scotland 80th Anniversary— That the Parliament congratulates One Parent Families Scotland on reaching the remarkable milestone of its 80th anniversary, and commends the charity for its unwavering dedication to empowering single parents to realise their full potential; recognises what it sees as the charity's crucial role in offering a comprehensive range of support services, including family, employability. young parent support, welfare rights, and financial advice through its five family centres in Dundee, Edinburgh, Falkirk, Glasgow and North Lanarkshire, as well as its national lone parent helpline and digital services; acknowledges that the charity, originally established in the 1940s as the Scottish Council for the Unmarried Mother and Her Child, was founded with a mission to keep unmarried mothers and their children together; celebrates the charity's extraordinary growth into an impactful organisation, employing 97 dedicated staff members, supporting over 8,000 parents, children, and young people each year, and providing what it considers to be life-changing welfare rights and financial advice that has, it understands, benefited nearly 4,000 families to date, resulting in financial gains for families exceeding £1.6 million; recognises that one in four families with children in Scotland are single-parent households, with 90% of these led by women; believes that, despite significant progress since the 1940s, gender inequality continues to fuel discrimination against many single mothers; understands the unique challenges faced by single parents combining the roles of sole carer and provider without the support of another adult, often facing a higher risk of poverty than other households; applauds the charity for its tireless advocacy for single parents at every level of government, working to create lasting solutions to what it sees as the widespread poverty that many face, and celebrates what it considers to be the remarkable resilience of single parents and the exceptional strength that they demonstrate every day in raising their families.

*S6M-14963 Alexander Stewart: Significant Sportscotland Cycling Facilities Award to Bike Trossachs CIC—That the Parliament welcomes the news that a cycling project in Mid Scotland and Fife region has received a facilities award from sportscotland; is enthused that an award to

Bike Trossachs Community Interest Company of £100,000 has been made towards a new pump track project; understands that with a total value £204,500, the project, managed by community group Bike Trossachs, will be built at Aberfoyle Bike Park as well as upgrades carried out to an existing skills area; hopes that this will give a significant boost to cycling participation and to cycling clubs in the area; considers that the work will increase the number of riders who can use the facility and provide an improved space for the community; notes that sportscotland's Cycling Facilities Fund (CFF) supports cycling facility projects that create or improve places where people take part in sport and physical activity; acknowledges that this news comes just over a year since Scotland, including events in Stirling, hosted the 2023 UCI Cycling World Championships; further understands that the £8 million CFF was established to build on the growing interest in cycling by developing a network of accessible facilities to encourage people of all ages to ride bikes and enjoy the sport; believes that the fund, administered by sportscotland and Scottish Cycling, has helped to provide accessible community and club facilities that inspire new and existing cyclists to make cycling a sport for life; notes that 45 facilities have now been funded through the CFF, and when contributions from partners to deliver the projects are factored in, over £13 million has been invested in cycling infrastructure through the fund so far, congratulates Bike Trossachs CIC on its significant award, and commends everyone involved, including sportscotland and Scottish Cycling, for everything that they do for cycling and for their communities.

*S6M-14957 Annie Wells: Charity Ball in Glasgow Raises £57,000 for Epilepsy Scotland—That the Parliament congratulates all those who attend the charity ball at the Marriott Hotel, Glasgow, on 12 October 2024 for raising £57,000 for Epilepsy Scotland; understands that the event marked the 70th anniversary of the charity and was attended by more than 250 guests; acknowledges the funds raised are crucial for the organisation, which needs more than £700,000 annually to provide social support for people affected by epilepsy; notes the evening saw the premiere of a short film about death and epilepsy, highlighting the reality that almost 300 people die from the condition each year in Scotland; recognises that there has been real progress made in epilepsy care over the past seven decades, including improvements in diagnostics, treatment and management, and notes that Epilepsy Scotland believes it could see a real reduction in the stigma that still attaches itself to the condition, which affects many on a daily basis.

*S6M-14956 Bob Doris: Kurdistan Region of Iraq Elections, 20 October 2024—That the Parliament welcomes the Parliamentary elections to the Kurdistan Region of Iraq on 20 October 2024; understands that the elections are reported to have been postponed on five occasions as a consequence of political differences over the electoral system, and that elections originally scheduled by the end of 2022 failed to transpire with the Kurdish Parliament then suspended in May 2023; acknowledges the ongoing concerns that the government of the semi-autonomous Kurdish Regional Authority must demonstrate greater transparency and tackle corruption within the region; further acknowledges the concerns of many within the Kurdish Region of Iraq that the Iraqi Government has precipitated a long-running financial crisis by withholding vital Kurdish revenues from the Baghdad government, allegedly to undermine the Kurdish Regional Authority and its pursuit of Independence, that consequently many public sector workers within the Kurdish Region have went unpaid or have had wages delayed; recognises that there are many Kurdish diaspora living in Scotland who care deeply about the future of the Kurdistan Region of Iraq, such as the Glasgow-based Kurdish Development Association, led by Mr Shakha Sattar and a team of volunteers, who have been encouraging the Kurdish diaspora with family and friends that remain within the region, along with the entire 2.9 million electorate, to exercise their democratic right to vote in these elections, and believes that, whatever the results, it must deliver for all those living in the Kurdish Region of Iraq a prosperous and peaceful future with an open and transparent

The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.
