### Members' Business motions that have not achieved cross party support

**\*[S6M-17011](#) Douglas Lumsden: Addressing Waiting Times in NHS Grampian**—That the Parliament notes the reported concerns regarding challenges that NHS Grampian is facing in relation to staffing shortages and resource limitations, which it understands has contributed to delays in patient care and increased pressure on existing medical personnel; acknowledges that, in September 2024, NHS Grampian reported that over 3,000 patients were waiting over two years for hospital treatment, which it believes was the highest number among Scottish NHS boards; understands that, in November 2024, NHS Grampian declared a board level critical incident, which led to the diversion of ambulance patients to hospitals outside the region due in part to sustained pressures at Aberdeen Royal Infirmary; notes that, in late November 2024, NHS Grampian experienced a significant rise in delayed discharges, with 199 cases, which according to the NHS board accounted for 13% of all beds in the region; believes that hospitals in the area are using outdated medical equipment, including an MRI scanner and an X-ray machine that are 15 and 27 years old, respectively, and notes the calls for the Scottish Government to develop an urgent plan to tackle what it regards as the ongoing issues within NHS Grampian that are impacting on patient care and service delivery.

**\*[S6M-17004](#) Rhoda Grant: Combatting Commercial Sexual Exploitation**—That the Parliament understands that prostitution is recognised by the Scottish Government as a form of violence against women; considers that, despite the Scottish Government's commitment to deterring demand for prostitution, it is currently legal to perpetrate this form of violence against women in Scotland, including in the Highlands and Islands region; further considers that Scotland is an attractive destination for sex traffickers due to pimping websites and paying for sex being legal; notes the findings of the report, *International Insights: How Scotland can learn from international efforts to combat commercial sexual exploitation*, which was published by the survivor-led campaign, A Model For Scotland; further notes the support for its conclusion that outlawing pimping websites and paying for sex, and decriminalising victims, is critical to reducing the demand that drives commercial sexual exploitation; understands that the right has been secured to introduce the proposed Prostitution (Offences and Support) (Scotland) Bill; believes that the United Nations Special Rapporteur on Violence Against Women and Girls recommends that states adopt the prostitution law reforms advocated by the campaign, A Model For Scotland, and contained in the proposed Prostitution (Offences and Support) (Scotland) Bill, and notes the calls

**\*S6M-17019 Kenneth Gibson: 100th Anniversary of the Skelmorlie Reservoir Disaster**—That the Parliament commemorates the 100th anniversary of the Skelmorlie Reservoir Disaster; understands that, on 18 April 1925, the Ayrshire village of Skelmorlie became the scene of a tragedy when the embankment of the lower reservoir, situated above the village, gave way, thus releasing millions of gallons of water; is aware that the fatal accident was caused by torrential rain on 17 and 18 April, leading to the lower reservoir filling to capacity; notes that, at around 2.00 pm, a 30-foot stretch of the embankment gave way, with the water surging down the steep hill with devastating force, carrying off any obstacles it encountered; understands that, within 10 minutes, the reservoir was empty, having claimed the lives of five villagers, Alexander and Frederick Dallas, Winifred Mary Menhennet, Janet Adam and Ursula Scott; notes that around 2,000 people attended the funeral service for the victims of the disaster, which was held in Skelmorlie Parish Church on 22 April 1925; acknowledges that a relief fund was set up at the Clydesdale Bank, Skelmorlie, to help the Dallas family, which had lost their two sons, home, and all their belongings; understands that an inquiry into the Skelmorlie Disaster was held at Kilmarnock Sheriff Court, on 22 June 1925, with Sheriff Principal W Lyon Mackenzie presiding, and that the jury returned a unanimous verdict that the accident had been caused by an absence of regular skilled inspection and maintenance of the reservoir; further understands that, after the disaster, in 1930, critical changes were made to reservoir safety legislation, and that, following their implementation, there have been no dam failures causing loss of life in Britain; praises Skelmorlie Community Council which, following a recent appeal for support for a memorial in the village from a research engineer, has worked hard to ensure that those who perished are remembered, and understands that there are various memorial plans and that the community council has indicated its willingness to take on ownership of the memorial, furnished by the British Dams Society, installing it in Skelmorlie community garden.
