S6M-16330 Jenny Gilruth: Addressing Child Poverty Through Education—That the Parliament notes the critical contribution made by education in eradicating child poverty, which is a national mission and the single greatest priority for the Scottish Government; notes recent analysis by the Joseph Rowntree Foundation, which highlights that Scotland will see a reduction in child poverty levels in the years ahead due to Scotland-specific policies, such as the Scottish Child Payment; further notes that the Scottish Government has committed to making further progress, and agrees that there is a collective responsibility for every local authority, and educational organisation and body in Scotland, to work together with the Scottish Government to address child poverty; commends Scotland's teachers and schools for their work to close the poverty-related attainment gap, and recognises that progress has been made, and that this programme will require more funding certainty over the longer term; welcomes the further investment in tackling child poverty through education in the draft Scottish Budget for 2025-26, including within schools through the expansion of free school meals, the uprating of the school clothing grant, continued funding for the Scottish Attainment Challenge and investment in Bright Start Breakfasts, as well as the around £1 billion investment in funded early learning and childcare and the £3.5 million investment in new skills pathways for colleges, and agrees that all MSPs across the Parliament have a responsibility to promote the interests of children and young people and to work together to share ideas and innovation to address child poverty through education.

The Presiding Officer has selected the following amendments

S6M-16330.4 Miles Briggs: Addressing Child Poverty Through Education—As an amendment to motion S6M-16330 in the name of Jenny Gilruth (Addressing Child Poverty Through Education), leave out from "welcomes" to end and insert "acknowledges that more than a quarter of children in Scotland live in poverty; recognises that, while investment in tackling child poverty through education is important, it must be accompanied by a focus on improving educational standards; notes that, while the Scottish Government has spent £1 billion on early years and childcare, there remains a significant disparity in the availability of early years provision across Scotland, which risks deepening inequalities and limiting parental employment opportunities, and has long-term consequences for children's development and educational outcomes; further notes with concern that education in Scotland has gone backwards in Programme for International Student Assessment (PISA) international rankings; acknowledges that the attainment gap in primary pupils' reading, writing, literacy and numeracy remains similar to pre-COVID-19-pandemic levels and has failed to close; regrets that the pledge to provide universal free school meals for primary pupils has not been fulfilled; expresses concern over the rising level of violence in schools, which negatively impacts both attainment and wellbeing; calls on the Scottish Government to provide greater support for teachers and local authorities to tackle this issue; further calls for a review of policies to improve the identification of and support for care

experienced and young carer pupils in schools, ensuring that they receive the necessary assistance to succeed in education, and believes that the Scottish Government's main priority should be ensuring that every child, no matter their background, has the best start in life."

S6M-16330.3 Pam Duncan-Glancy: Addressing Child Poverty Through Education—As an amendment to motion S6M-16330 in the name of Jenny Gilruth (Addressing Child Poverty Through Education), leave out from ", which is" to end and insert "; commends Scotland's teachers and schools for their work; notes that the poverty-related attainment gap has not improved in P1 and is the widest it has ever been at Higher level; further notes that the Scottish Government's failure to plan for the school workforce has meant that teachers are often overworked and children are unsupported; expresses its disappointment at what it sees as the Scottish National Party's broken promise of rolling out free school meals to all P6 and P7 pupils; believes that education should set young people on the path to opportunities for their future and can help lift people out of poverty; understands that 'Scotland's colleges play a particularly important role in supporting learners from more deprived communities to access learning, as described by Audit Scotland, but that the 'financial health of the sector has deteriorated since 2021-22'; welcomes that 100,000 people in Scotland have already received a pay rise thanks to the UK Labour administration's New Deal for Working People: acknowledges recent analysis by the Joseph Rowntree Foundation on the extent of child poverty in Scotland, which observed deficiencies in the key data used to calculate poverty rates and found that 'we will need to go further to reach the 2030-31 targets', and calls on the Scottish Government to work with the UK Department for Work and Pensions to ensure that accurate data is available for the Joseph Rowntree Foundation and other organisations to accurately assess the extent of child poverty in Scotland and the impact of policy interventions on it."

\*S6M-16353 Jenni Minto: Improving Miscarriage Care—That the Parliament recognises the devastating impact that miscarriage and stillbirth can have on women and their families, and extends its condolences to all those who have been affected; acknowledges the importance of good stillbirth care and that improvements continue to be made by NHS boards and through the stillbirth national bereavement care pathway; notes that, although miscarriage care in Scotland is generally considered to be of high quality, there is still more to do to standardise and end the variation in the care and support delivered across Scotland; welcomes efforts from NHS boards to further improve miscarriage care following recommendations in *The Lancet* series, *Miscarriage* Matters, and Royal College of Obstetricians and Gynaecologists and NICE guidelines around the use of progesterone; thanks hardworking NHS staff and all those who have contributed to the progress to date for their care and professionalism when caring for women experiencing miscarriage; welcomes the publication of the Delivery Framework for Miscarriage Care in Scotland and the Progesterone Pathway as key steps in implementing a graded model of care that will ensure that women receive tailored support from their first miscarriage; supports the provision of dedicated facilities for women experiencing unexpected pregnancy complications, miscarriage or still birth, and believes that it is vital that everyone in society, including employers, works together to break the stigma surrounding miscarriage and stillbirth to ensure that women and their families can access the information, care and support that is right for them.

by the Joseph Rowntree Foundation, which highlights that Scotland will see a reduction in child poverty levels in the years ahead due to Scotland-specific policies, such as the Scottish Child Payment; further notes that the Scottish Government has committed to making further progress, and agrees that there is a collective responsibility for every local authority, and educational organisation and body in Scotland, to work together with the Scottish Government to address child poverty; commends Scotland's teachers and schools for their work to close the poverty-related attainment gap, and recognises that progress has been made, and that this programme will require more funding certainty over the longer term; welcomes the further investment in tackling child poverty through education in the draft Scottish Budget for 2025-26, including within schools through the expansion of free school meals, the uprating of the school clothing grant, continued funding for the Scottish Attainment Challenge and investment in Bright Start Breakfasts, as well as the around £1 billion investment in funded early learning and childcare and the £3.5 million investment in new skills pathways for colleges, and agrees that all MSPs across the Parliament have a responsibility to promote the interests of children and young people and to work together to share ideas and innovation to address child poverty through education.

\*S6M-16330.4 Miles Briggs: Addressing Child Poverty Through Education—As an amendment to motion S6M-16330 in the name of Jenny Gilruth (Addressing Child Poverty Through Education), leave out from "welcomes" to end and insert "acknowledges that more than a quarter of children in Scotland live in poverty; recognises that, while investment in tackling child poverty through education is important, it must be accompanied by a focus on improving educational standards; notes that, while the Scottish Government has spent £1 billion on early years and childcare, there remains a significant disparity in the availability of early years provision across Scotland, which risks deepening inequalities and limiting parental employment opportunities, and has long-term consequences for children's development and educational outcomes; further notes with concern that education in Scotland has gone backwards in Programme for International Student Assessment (PISA) international rankings; acknowledges that the attainment gap in primary pupils' reading, writing, literacy and numeracy remains similar to pre-COVID-19-pandemic levels and has failed to close; regrets that the pledge to provide universal free school meals for primary pupils has not been fulfilled; expresses concern over the rising level of violence in schools, which negatively impacts both attainment and wellbeing; calls on the Scottish Government to provide greater support for teachers and local authorities to tackle this issue; further calls for a review of policies to improve the identification of and support for care experienced and young carer pupils in schools, ensuring that they receive the necessary assistance to succeed in education, and believes that the Scottish Government's main priority should be ensuring that every child, no matter their background, has the best start in life."

\*S6M-16330.3 Pam Duncan-Glancy: Addressing Child Poverty Through Education—As an amendment to motion S6M-16330 in the name of Jenny Gilruth (Addressing Child Poverty Through Education), leave out from ", which is" to end and insert "; commends Scotland's teachers and schools for their work; notes that the poverty-related attainment gap has not improved in P1 and is the widest it has ever been at Higher level; further notes that the Scottish Government's failure to plan for the school workforce has meant that teachers are often overworked and children are unsupported; expresses its disappointment at what it sees as the Scottish National Party's broken promise of rolling out free school meals to all P6 and P7 pupils; believes that education should set young people on the path to opportunities for their future and can help lift people out of poverty; understands that 'Scotland's colleges play a particularly important role in supporting learners from more deprived communities to access learning', as described by Audit Scotland, but

that the 'financial health of the sector has deteriorated since 2021-22'; welcomes that 100,000 people in Scotland have already received a pay rise thanks to the UK Labour administration's New Deal for Working People; acknowledges recent analysis by the Joseph Rowntree Foundation on the extent of child poverty in Scotland, which observed deficiencies in the key data used to calculate poverty rates and found that 'we will need to go further to reach the 2030-31 targets', and calls on the Scotlish Government to work with the UK Department for Work and Pensions to ensure that accurate data is available for the Joseph Rowntree Foundation and other organisations to accurately assess the extent of child poverty in Scotland and the impact of policy interventions on it."

The Testament of Gideon Mack; believes that Brownsbank Cottage has made an indelible imprint on Scottish cultural heritage and that its preservation, with immediate works required, is a cultural priority; commends the board of trustees and volunteers of MacDiarmid's Brownsbank on what it sees as their tireless efforts to protect and promote this historical Scottish landmark; notes the view that the protection and development of Scotland's literacy heritage is vital to the nation's cultural health, identity and confidence, and further notes the calls for the Scottish and UK governments to assist with the restoration of Brownsbank Cottage, to preserve this historic and national treasure.

\*S6M-16289 Bill Kidd: The Doomsday Clock Reaches 89 Seconds to Midnight—That the Parliament acknowledges that the *Bulletin of the Atomic Scientists* has set its Doomsday Clock to 89 seconds to midnight, the closest it has ever been; notes that this has moved from three minutes to midnight in 2015 to 89 seconds now due to what the scientists see as the increasing risks posed by nuclear weapons, climate change and artificial intelligence; considers that, as the 80th anniversary of the bombings of Hiroshima and Nagasaki approaches, the threat of nuclear weapon use is at an unprecedented level, exacerbated by a 34% increase in nuclear arsenal spending over the past five years; emphasises what it sees as the importance of the UN Treaty on the Prohibition of Nuclear Weapons (TPNW) as a critical diplomatic tool to address this threat; notes that the next meeting of states' parties to the TPNW will be held in New York from 3 to 7 March 2025, and calls on the UK Government to actively engage with the TPNW.

\*S6M-16257 Kenneth Gibson: The Presidential Election in Belarus—That the Parliament condemns the recent Belarussian presidential election, which took place on 26 January 2025, and which it believes to be a sham; notes reports that no independent observers monitored the vote in Belarus, which, it understands, has also shut down all of its independent media; highlights that the Central Election Commission declared incumbent President Lukashenko the winner with nearly 87% of the vote, in an election where, it believes, all credible opposition figures were either jailed or exiled; expresses concern at reports that the pro-Russian Belarusian regime under President Lukashenko routinely persecutes people who stand up for democracy, the rule of law and human rights, as well as marginalised groups; notes that Alexander Lukashenko has been in power since 1994 and is often referred to as "Europe's Last Dictator"; believes that Lukashenko made his country a launchpad for Russian President Vladimir Putin's full-scale illegal invasion of Ukraine: recognises the work of the Liberco Partnership for Human Rights in raising awareness of the Belarussian political prisoners that it considers are languishing in Lukashenko's jails; acknowledges that the exiled opposition leader, Sviatlana Tsikhanouskaya, who claimed victory in the 2020 election in which she stood in place of her jailed husband, reportedly dismissed the recent election as fraudulent; believes that this ongoing situation is an affront to democracy, and urges the international community to support the people of Belarus in their fight for democracy and human rights

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.
