S6M-15413 Michelle Thomson: Promoting the Role of Women in Scotland's Journey to Net **Zero**—That the Parliament recognises what it sees as the importance of women in business as Scotland strives to achieve net zero targets; understands that there is a need to stimulate more innovation and entrepreneurship amongst STEM-based sectors to contribute directly to building capacity in Scotland, including in the Falkirk East constituency, and recognises that the wider business sectors also have a role to play in achieving net zero; welcomes the July 2024 Global Entrepreneurship Monitor (GEM) report, and particularly the analysis provided by Glasgow, Edinburgh and Strathclyde universities regarding female entrepreneurship in Scotland; celebrates the finding that women are starting and running new businesses at virtually the same rate as men for the first time in Scotland, and that, globally, the female to male gap in entrepreneurship rates is narrowing, and believes that Scotland is leading the way by this measure; considers, therefore, that women entrepreneurs and business leaders will be a vital resource in leading Scotland's economy towards growth and net zero, but believes that, post-school, the number of females entering STEM-related education, employment or business start-ups remains weak; understands that a 2023 report by Women's Enterprise Scotland expressed concern that approximately 60% of women-led businesses are somewhat disengaged from achieving net zero, either because of a lack of confidence or a belief that it does not apply to their operations; further understands that a fear of failure is a key cultural barrier to further developing entrepreneurial activity in Scotland at a time when innovation and entrepreneurship will, it believes, be vital to meeting the challenge of achieving net zero, and notes the calls for both effective representation of women in all net zero policy forums and further research into the contribution of women directly in STEM-based businesses and wider business sector activity as net zero is pursued.

*S6M-16194 Elena Whitham: Common Ground Forum on Deer—That the Parliament recognises the recent Nature of Scotland Award for Innovation to the Common Ground Forum for its work addressing challenging conflicts and relationships in the deer management sector; welcomes that the forum has brought together stakeholders, including land managers and conservationists, to build consensus and common understanding; notes what it sees as the importance of effective deer management, both in achieving nature restoration and the viability of rural businesses in many parts of the country, including in Carrick, Cumnock and Doon Valley, and notes the view that all sides of the deer sector should continue to embed the Common Ground Forum's approach.

*S6M-16168 Kenneth Gibson: The Impact of Increased Employers National Insurance **Contributions** —That the Parliament notes with concern the impact of increased employers national insurance contributions (ENIC) from 6 April 2025 across the Scottish economy and, specifically, the public and third sectors: understands that the Scottish Government estimates that the direct cost to the public sector at £549 million in 2025-26, excluding "on costs", such as rising procurement inflation, due to ENIC increases; believes that the impact on the third sector, universities and independent care providers will collectively be £210 million in 2025-26; acknowledges the Office for Budget Responsibility's view that 75% of ENIC costs will fall on employee pay; believes that this will hit the lowest paid hardest, with 25% being paid for by reduced business investment; acknowledges that Secretary of State for Scotland, the Rt Hon Ian Murray MP confirmed on 7 November 2024 that "the UK Government will provide funding to the public sector to support with the additional costs associated with these changes", but that no confirmation of how much funding has yet been provided to the Scottish Government, and notes the view that the UK Government should fully fund the cost of ENIC increases on the Scottish public sector as promised, as well as the third sector, independent care providers and universities, to ensure no detriment to the people and communities of Cunninghame North and those across Scotland.

*S6M-16155 Mark Ruskell: Save Local Libraries—That the Parliament notes what it sees as the vital role that local libraries play in their communities, acting as central hubs for borrowing, learning, community engagement and sourcing advice and support; believes that the closure of libraries leaves communities without these vital services, and that this is particularly damaging for rural areas where libraries can be heavily relied on; considers that library closures have a disproportionate impact on vulnerable populations, including children, older residents and people with limited access to digital resources; notes the reported concerns raised by communities around the proposed closure of libraries across Scotland, including the threatened closure of those in the Perth and Kinross Council area; understands that local authorities have a legal obligation to provide public library services; believes that mobile libraries are often not suitable alternatives; considers that library services require adequate public funding to remain viable and have a critical role to play in achieving the Scottish Government's priorities, including eradicating child poverty; believes that a closed library is unlikely to reopen, permanently limiting opportunities for the communities they once served, and notes the calls on the Scottish Government to help protect the future of Scotland's libraries.

Proposals for Member's Bills

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.
