Interests

Murdo Fraser (Mid Scotland and Fife) (Con): Good morning, and welcome to the first meeting in session 6 of the SPCB Supported Bodies Landscape Review Committee.

I have the pleasure of convening the meeting for the first two items of business. By convention, the oldest member of the committee has to convene the opening of the first meeting. For the avoidance of doubt, I state on the record that I am not the oldest member of the committee—just in case there was any doubt about that.

We have received apologies from Richard Leonard MSP, who is the oldest member of the committee but cannot be with us this morning. That leaves me, as the second-oldest member, to convene the meeting. However, for the record, I reiterate my entry in the register of members' interests, which states that I used to work for Orbital Marine Power, which is a tidal energy company. I am also a member of Unite the union.
